

ENVIRONMENTAL COMMITTEE Meeting Minutes

New Port Richey – Public Library Thursday –June 1, 2023 – 6:00 p.m.

The Environmental Committee of the City of New Port Richey develops and endorses environmental events in the City, renders annual and special reports as members may deem advisable, and explores new environmental initiatives for the City. The ECCNPR was established in 1989 and recreated in 2011.

Welcome

Vox Pop (3 minutes for members of the audience – on items not on the agenda) Terri lives on Montana Avenue. D'Anne lives on Delaware. Sable Palm Alley runs behind properties on Montana and Delaware but dead ends behind D'Anne and Terri's properties. The City wants to reopen the alley, at least in part. Grand old trees could be cut down, and it appears that Gopher Tortoises would be impacted. The City has asked Terri to move a shed that was constructed in her backyard, even though the City permitted and inspected the structure only seven years ago. Terri said she was working on a petition for her neighbors to sign.

By unanimous vote, the Environmental Committee recommends that no further action be taken on the City's direction given to the property owner of 5538 Montana Avenue until further investigation is completed.

Update on inclusion of City Property in Urban Agriculture Ordinance

* Report on select city-owned properties for proposed community gardens (report from Tom)

Tom has been researching assorted City properties for the possible building of more Community Gardens. He recommends Frances Avenue Park. He found other cities around the nation that have ordinance and permit language that can be given to our City to possibly move the process forward. Dell and Tom will work on this.

Urban Agriculture Program (committee member needed for leadership) * Daniella said she would try to get the applications on the City Website. Andi said she can oversee the Library's part in the process.

Library Seed Lending Program (Amber and Andrea) – Amber delivered dozens of paper seed envelopes for the Seed Library. These were constructed by Agriculture students at Hudson High School.

Fruit Tree Peninsula (Linda) - Linda and Don weeded the Butterfly Garden at the Fruit Tree Peninsula, applied a generous amount of mulch/soil (from the City's Yard Debris to Mulch program), uncovered five thriving butterfly plants (Firebush, Tropical Milkweed, Blue Porterweed, Pellitory and Scarlet Salvia) and planted a Beauty Berry Bush.

* Here is the language from our 2022 Annual Report: A companion proposal establishes a program to allow native vegetation to flower in the spring to nourish insect and bird populations to thrive during breeding season. Dubbed "No Mow May" in other areas, the program encourages property owners not to mow during the month of May to allow native plants a change to flower. Here, we'd probably have to go with No Mow April and May.
