

## **RESOLUTION NUMBER 2016-14**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NEW PORT RICHEY, FLORIDA AMENDING THE COMPREHENSIVE TABLE OF FEES FOR SPECIAL EVENTS AND QUEEN OF PEACE HALL; INCLUDING NEW FEES FOR PARK DAMAGE; ESTABLISHING A REQUIREMENT FOR CARNIVAL BOND; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City Council of the City of New Port Richey adopted Resolution No. 2015-22 on September 23, 2015 which established the Comprehensive Table of Fees; and

**WHEREAS**, user fees and charges are essential to offsetting some of the administrative maintenance and operating costs incurred by the City in providing parks and recreation facilities and services; and

**WHEREAS**, the City Council of the City of New Port Richey deems it in the best interest of the citizens of the city to update and approve the Comprehensive Table of Fees for special events and Queen of Peace Hall to more equitably assess the cost of these services to parties directly benefiting from those services or functions offered and/or provided.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of New Port Richey, Florida that:

- 1.) The City Council of the City of New Port Richey hereby adopts the amended Comprehensive Table of Fees as set forth in Exhibit A, attached hereto and incorporated herein by reference, effective immediately;
- 2.) The fees listed in Exhibit A do hereby supersede and replace the fees previously adopted by City Council to the extent the fees listed are promulgated for the same service;
- 3.) All other fees listed in the previously adopted Comprehensive Table of Fees shall remain in full force and effect.
