Executive Director Manns introduced the item to the Directors and stated Ms. Feast would make the presentation to them. Ms. Feast stated that corrected copies of the CRA budget were provided at the dais. The total expenditures are estimated to be \$2,506,495. Director Marlowe opened the floor for public comment No one coming forward Director Marlowe closed public comment and returned the floor to the Directors. Director Phillips asked staff that if corrections are made to make them aware of what the changes were as this was the third time in the last three meetings that information was changed prior to the meeting. He stated he still has issues of the CRA being a debt service fund and showing transfers from this fund into the general fund. The CRA was meant to be an overlay on the city for additional ad-valorem dollars. The CRA has specific elements that it can fund itself. The CRA has a specific purpose and we are not meeting the benchmarks.

Resolution 2016-26 to adopt the tentative operating budget for FY2016/2017 was adopted by a vote of 5-0 at 8:12 p.m.
