- Richey Elementary Remodel (2013) \$16.5 million investment
- Marlowe Elementary Remodel (2021) \$6 million investment
- Mittye P Locke Conversion (2023) \$2 million investment
- Gulf High School Remodel (2024) \$63 million investment
- Gulf Middle Remodel (2025) \$72 million investment
- Achieve Center (2025) Expanding program and relocating to Locke











New Port Richey Schools Academic Overview







• Designated Assistant Superintendent for School Improvement

A dedicated leader in place to oversee targeted improvement efforts at Richey Elementary and Gulf Middle School.

Khanamigo Al Tutoring (Gulf Middle & Gulf High - Coming Soon)

Students will benefit from AI-powered tutoring and academic support through Khanamigo, an innovative online learning platform.

New Elementary Math Curriculum Adoption

Savvas Math has been adopted to better align with Florida's B.E.S.T. Standards and build a strong foundation in math skills for all elementary students.

Academic Action Plan



Academic Coaches at Every Site

Each school is supported by on-site academic coaches focused on instructional excellence and student growth.

Structured Intervention Support Time

Allocated time during the school day for focused interventions, tailored to meet student needs.

Rebranding and Remodeling Projects

- Gulf High School: Rebrand and remodel completed
- Gulf Middle School: Planned rebranding and remodeling efforts beginning this summer 2025.

Mittye P Locke Program Changes



Relocation of Early Learning Programs

- Pre-K programs currently based out of Locke will be integrated into existing programs at elementary schools throughout West Pasco.
- Head Start programs currently based out of Locke will transition to a new Metropolitan Ministries facility, classes will be staffed with Pasco County teachers.

Mittye P Locke Program Evolution

- The site will now house the Achieve Center currently at Richey Elementary.
- This relocation will allow space for the creation of a new **transition program** for 4th and 5th graders with behavioral challenges and learning gaps in order to better prepare them for middle school.

Gulf Middle School Construction Overview



Project Timeline Overview

- •Summer 2025 Begin construction of the new school building
- •Fall 2026 Complete construction of the new building
- •January 2027 Instruction begins in the new facility
- •Spring-Summer 2027 Raze existing buildings and complete all remaining site work
- •Summer 2027 Total project completion


